1 OPEN FORUM

No issues were raised.

2 DECLARATIONS OF INTEREST

No declarations of interest were raised.

3 MINUTES

The minutes of the meeting held on the 6th May having been circulated to members were declared correct and signed by the Chairman.

4 PLANNING

New applications

The following applications were reviewed:

20/01142 Skagen House, Bethesda Street, New Garage & Carport

The Parish Council reviewed the application and objected on the following grounds:

When the application for the house was originally raised in 2016 a garage in front of the property was included and this had to be removed prior to approval being granted. The Parish Council believe the new building will dominate the plot, represents over development and is yet another example of design by stealth within the Parish.

20/01055/56 Walnut Tree Cottage, Blandys Lane, New Outbuilding

The Parish Council reviewed the application and objected on the following grounds:

The forms for the proposal haven't been fully completed and lack detail in places. As a result, the Council were unclear on certain aspects of the plans.

The new building is twice the size of that which it replaces and is more of a new build than the plans suggest. The effect on the grade II listed Walnut Tree should be followed up by the conservation officer.

5 REVIEW OF OPEN ACTIONS

Covid 19 updates for various areas of the village were discussed. No issues were raised.

The Rospa safety report for the two play parks in the Parish has been rereviewed. Councillor Chadwyck-Healey has been given the relevant contractor details and will proceed with quotes.

The Chairman confirmed that a reporting pack for the last year's council activity is almost complete and ready for the website.

The chairman will follow up the clean up of street signs within the Parish and will talk to a contractor regarding the cutting back of encroaching bushes etc. The clerk will contact West Berkshire Council to see if this should fall under their care otherwise the Parish will fund the activity.

The chairman will write to the local MP regarding the 'SLOW' signs on the Pangbourne Road and request assistance in getting these re-painted.

Councillor Czjaka will contact the company who engraved the war memorial (Walkers) regarding a site visit and potential tidy up.

6 FOOTPATHS, HIGHWAYS AND OPEN SPACES

Footpaths continue to be well used and some have been cut back during the last month (footpaths 3 and 7).

Footpath 17 needs to be cut back and footpath 5 is also a little overgrown in places. Councillor Cox will make the necessary arrangements.
