### **5 REVIEW OF OPEN ACTIONS**

Councillor Chadwyck-Healey updated the meeting on the proposed purchase of further play equipment for the two recreation grounds in the Parish. For the Village Hall, a basketball hoop is proposed; two quotes have been received with the clerk will liaising with the Village Hall trustees over potential locations before an order is placed. For the Park at Wakemans, quotes for a large swing have been obtained and Councillor Chadwyck-Healey will look and advise on a suitable location. The Parish Council were happy to proceed with the cheaper of the two quotes.

Councillor Greasley has written to the Country Neighbour regarding clubs and societies and the potential for one off grants to be offered by the Parish Council. Interested parties should contact the clerk in the first instance with any proposal.

Councillor Larkin attended the climate forum and reported back on the main topics raised. Of note were a residents energy switching scheme which will be added to the Parish Council website, details of further tree planting in the local (county) area and a discussion over further recycling.

The Clerk has chased up West Berkshire Council regarding additional litter bins as no response has been received.

The invitation for a Beale Park representative to attend a Parish Council meeting has been followed up.

The Clerk confirmed that he will speak to the Youth club trustees regarding table tennis tables for the recreation ground as these were believed to have been proposed previously.

### 6 FOOTPATHS, HIGHWAYS AND OPEN SPACES

Footpaths are a little overgrown in places although some cut back has occurred in places. The Clerk will inform West Berkshire Council of any issues that arise and will follow up the request to West Berkshire Council to cut back the area between Hook End Lane and Church Lane on the A329. Additionally, Hook End Lane will be checked following reports that it is overgrown.
